

**LIVONIA TOWN COUNCIL
REGULAR MEETING
April 10, 2023 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on April 10, 2023, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order. Roll call resulted as follows:

APPROVAL OF MINUTES

A motion was made by Mr. T. Jarreau, seconded by Ms. Pourciau, and carried to approve and publish the minutes as written from the regular meeting on March 13, 2023.

APPROVAL OF TREASURER’S REPORT

A motion was made by Mr. LeBlanc, seconded by Mr. Watson, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

APPROVAL OF INVOICES

A motion was made by Mr. LeBlanc, seconded by Mr. G. Jarreau, and carried, to approve the invoices for payment.

REQUEST TO CHANGE PROPERTY TO RENTAL

A request was made by Ms. Jessica Rodriguez to change her residential property at 8493 Bergeron Street to rental property. After all required documentation was presented and reviewed, a motion was made by Mr. G. Jarreau to approve the request. Motion was seconded by Mr. LeBlanc and carried.

ZONING COMMITTEE RECOMMENDATION – Chairman Mark Barrios

Mr. Barrios reported that a Public Hearing was held on March 21, 2023, at 6:00 p.m. regarding the rezoning of 3189 LA HWY 78 from Residential 1 to Commercial 1A. The property will be used by Ms. Kathleen Fontenot for Every Day Counts – ABA Therapy Center, which works with students with developmental disabilities, including autism. All present committee members agreed to the rezoning and recommended the Town Council agree to the rezoning also.

INTRODUCTION OF ORDINANCE – Rezoning

Mr. G. Jarreau introduced an ordinance to amend and reenact Section 17.29 Zoning Map to rezone 3189 LA HWY 78 from an R1 to C1A. Mr. T. Jarreau seconded the motion and carried.

RESOLUTION – SURPLUS PROPERTY

A resolution was offered by Mr. G. Jarreau to identify one used police unit partition cage as surplus property and to donate it to Olla Police Department. Motion was seconded by Mr. T. Jarreau and Resolved.

DEPARTMENTAL REPORTS

Police Report – Police Chief Landon Landry

In March, 459 citations were issued with 9 warnings. Two traffic accidents/incidents were worked, 42 complaints were answered, and 1 arrest was made. Fines collected for the month were \$72,652.

Each Council Member gave brief updates on their departments.

MAYOR'S REPORT – Rhett Pourciau, Mayor

Upon recommendation by Mayor Pourciau, a motion was made by Mr. G. Jarreau, seconded by Mr. LeBlanc, and carried to change from Mayor's Court to Magistrate's Court and enter into a contract with Mr. Steve Marionneaux as Magistrate and Ms. Ashley Woods as Prosecutor. Each position will receive \$450 per month.

A motion was made by Ms. Pourciau, seconded by Mr. G. Jarreau, and carried to adjourn the meeting at 6:55 p.m.
