

**LIVONIA TOWN COUNCIL  
REGULAR MEETING  
August 8, 2022 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on August 8, 2022, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

**APPROVAL OF MINUTES**

A motion was made by Mr. G. Jarreau, seconded by Mr. T. Jarreau, and carried to approve and publish the minutes as written from the regular meeting on July 11, 2022.

**APPROVAL OF TREASURER’S REPORT**

A motion was made by Mr. LeBlanc, seconded by Ms. Pourciau, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

**APPROVAL OF INVOICES**

A motion was made by Mr. T. Jarreau, seconded by Mr. G. Jarreau, and carried, to approve the invoices for payment.

**REQUEST TO REVISIT PARISH ANIMAL CONTROL PROPOSAL**

Mr. Richard Hirsch stated that after obtaining more information regarding the Council’s decision to rescind their motion approving the proposal by Pointe Coupee Parish Government, he then understood and agreed. He added there is a problem with stray animals throughout the parish and it’s a public health problem.

Upon Mr. Hirsch’s suggestions, Mayor Pourciau stated that he would speak with Parish President Major Thibaut about alternative ways to remedy the problem.

**RESOLUTION – Hire Engineer for Water Sector – Round 2.**

Proposals were received, evaluated, and scored for engineering services for Round 2 of the American Rescue Plan (Water Sector Program). A Resolution was offered by Mr. G. Jarreau to choose Owen and White, Inc. as the engineer for this project. Motion was seconded by Mr. T. Jarreau and Resolved.

**DEPARTMENTAL REPORTS**

***Police Report –Police Chief Landon Landry***

In July, 522 citations were issued with 53 warnings. Three arrests were made, and 53 complaints were answered. Fines collected for the month were \$58,876.

- Upon recommendation by Chief Landry, a motion was made by Mr. LeBlanc to increase the fines as submitted effective September 1, 2022. Motion was seconded by Mr. Watson and carried.
