DEPARTMENTAL REPORTS

Police Report - Police Chief Landon Landry

In November, 224 citations were issued with 4 warnings. Five traffic accidents/incidents were worked and 37 complaints were answered. Fines collected for the month were \$88,592 of which \$33,310 of that amount was from handheld radar citation collections.

Issues with trash, travel trailer occupants, and other violations at the rental property owned by Mr. Brent Beauvais on US HWY 190 have been addressed with the tenants and the property owner.

Public Works and Utilities – Ricky David

- The main water line upgrade on LA HWY 78 has been completed.
- Drawing and specifications have been completed by the engineer to address the sewer plant issues next month.
