# Police Report - Police Chief Landon Landry

In December, 350 citations were issued with 8 warnings. Three traffic accidents/incidents were worked, and 46 complaints were answered. Fines collected for the month were \$63,181.10.

Part-time officer Ned Tolliver resigned due to time constraints with his other employment commitments.
