#### Police Report – Police Chief Brad Joffrion

During the month of June, 618 citations were issued with 1 warning. Four arrests were made, 4 traffic accidents/incidents were worked, and 82 complaints were answered. Fines collected for the month were \$66,018.

- Opelousas Police Department finally picked-up and paid for the 2010 Tahoe.
- The J-turns on US HWY 190 are working very well.

## Council Member James Bergeron – Drainage and Abandoned Vehicles

DOTD cleaned the ditches along a portion of LA HWY 78, according to recommendations, to allow Mr. Keith Davidson to install culverts on his property at Cooley and LA Hwy. 78 without causing possible flooding issues.

## Council Member Greg Jarreau – Water, Gas, and Dangerous Structures

Since the resignation of Assistant Public Works Director Robert Otremba, Mr. G. Jarreau made a motion to advertise for job openings for Utility and Street Department Laborers. Motion was seconded by Mr. Bergeron and carried.

Mr. G. Jarreau and Mr. LeBlanc agreed to revisit the current salary ranges and research comparisons.

# Council Member Terry Jarreau – Grass and Baseball Program

The town had to cut two areas that were not in compliance with the town's grass restrictions. Two more notices will go out this week for tall grass.

# Public Works – Public Works Director Ricky David

- The culverts have been delivered and the project will begin soon on the Church Street drainage project.
- Charles Bates is currently assisting the Utility Department when needed.
