# LIVONIA TOWN COUNCIL REGULAR MEETING

July 8, 2019

The Livonia Town Council met in regular session at 6:30 p.m. on July 8, 2019, in the Livonia Council Chambers, 3111 LA Hwy. 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

## **AGENDA AMENDMENT**

Mr. T. Jarreau made a motion to amend the agenda to include Mr. Renee' Thibodeaux, Candidate for Pointe Coupee Parish Sheriff. Motion was seconded by Mr. G. Jarreau and unanimously approved.

#### **APPROVAL OF MINUTES**

A motion was made by Mr. T. Jarreau, seconded by Mr. LeBlanc, and carried to approve the minutes as written from the regular meeting on June 10, 2019.

A motion was made by Mr. LeBlanc, seconded by Mr. Pourciau, and carried to approve the invoices from Livonia Auto Repair for payment with Mr. G. Jarreau abstaining.

#### CANDIDATE FOR SHERIFF

Mr. Renee' Thibodeaux announced his candidacy for Pointe Coupee Parish Sheriff. He stated his qualifications, and his goals for the parish when elected sheriff.

#### PUBLIC HEARINGS ON CONDEMNATION OF PROPERTY

**A.** Mayor Pourciau opened the public hearing on the proposed condemnation of 8095 Airline Highway and asked Mr. Thomas David, building inspector for the town, to give his report.

Pan American Engineers, LLC has made an inspection of the structure located at 8095 Airline Highway described as 9.2 Acres: Track being front portion of 103A Tract (Guerin's Bar), Town of Livonia, Louisiana, 70755, and has prepared a report of Structural Inspection, which recommends that the Mayor and Town Council demolish and/or remove the structure due to its dilapidated and dangerous condition which endangers the public welfare.

The property owner, as shown in the records of the Pointe Coupee Parish Assessor's Office is Sammie Guerin, P.O. Box 445, Livonia, Louisiana 70755. The property owner was attempted to be served notification to appear at said hearing by the Town of Livonia. The property

owner/representatives, Suzanne Bergeron and Grace Merrill, were present at said hearing and stated they plan to sell the property.

Mayor Pourciau closed the public hearing after discussing further.
