

**LIVONIA TOWN COUNCIL
REGULAR MEETING
June 10, 2024 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on June 10, 2024, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call roll which resulted as follows:

THE FOLLOWING WERE APPROVED

MINUTES: Motion by Mr. T. Jarreau, seconded by Mr. Watson, and carried to approve and publish the minutes as written from the regular meeting on May 13, 2024.

TREASURER’S REPORT: Motion by Mr. T. Jarreau, seconded by Mr. LeBlanc, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

INVOICES: Motion by Mr. LeBlanc, seconded by Mr. G. Jarreau, and carried, to approve the invoices for payment.

AWARD CONTRACT ON DEMOLITION OF 8813 AIRLINE HIGHWAY

Sealed bids were opened on Monday, June 10, 2024, for the demolition and removal of house and junk at 8813 Airline Highway. Mr. LeBlanc motioned to award the contract to the lowest bidder, Waste Depot, for \$9,500. Motion was seconded by Mr. G. Jarreau and carried.

RESOLUTION – Official Journal

A resolution was offered by Mr. LeBlanc to select The Pointe Coupee Banner as the Official Journal for the Town of Livonia for a term of one year. Seconded by Mr. T. Jarreau and resolved.

ENGINEER’S REPORT – Mr. Gregg Gautreaux

Bids for sludge and debris removal at the wastewater treatment plant were rebid and bids were opened on June 10, 2024. Mr. G. Jarreau made a motion to award the contract to Key Construction Services for \$94,980. Motion was seconded by Mr. Watson and carried.

Police Report – Police Chief Landon Landry

In May, 338 citations were issued with 5 warnings. Three traffic accidents/incidents were worked, 1 arrest made, and 46 complaints answered. Fines collected for the month were \$79,700.

State legislators made changes to the photo enforcement laws which will require the police department to make some adjustments to what is already in place.

Each Council Member gave brief updates on their departments.

Council Member Henry Watson presented a grant proposal through the Recreational Trails Program which if funded would provide a walking path around the Indian Mound and other related projects. Council agreed to wait until the next application period since the deadline was June 30, 2024, and more information and planning were needed before a decision could be made regarding the application.

MAYOR’S REPORT – Mayor Rhett Pourciau

The Red Hat Gators of Livonia are sponsoring a Blood Drive on July 3, 2024, at Soprano's Supermarket, from 11:00 am until 6:00 pm. Door prizes will be given out. The Town of Livonia is in support of this and everyone is encouraged to donate blood, if possible.

An amendment to the Zoning Ordinance is recommended regarding verbiage of the C2 class defining commercial and industrial. Council agreed to contact the Zoning Committee on this recommendation.

PUBLIC COMMENTS

Mr. Brian Bergeron announced his candidacy for Town Council in the fall election.

A motion was made by Mrs. Pourciau, seconded by Mr. G. Jarreau, and carried to adjourn the meeting at 7:30 p.m.
