

**LIVONIA TOWN COUNCIL  
REGULAR MEETING  
March 14, 2022 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on March 14, 2022, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

**AMEND AGENDA**

A motion was made by Mr. G. Jarreau to amend the agenda to add Everyday Counts (Applied Behavior Analysis). Motion was seconded by Ms. Pourciau and unanimously approved.

**APPROVAL OF MINUTES**

A motion was made by Mr. LeBlanc, seconded by Mr. Watson, and carried to approve and publish the minutes as written from the regular meeting on February 14, 2022.

**APPROVAL OF TREASURER’S REPORT**

A motion was made by Mr. T. Jarreau, seconded by Mr. LeBlanc, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

**APPROVAL OF INVOICES**

A motion was made by Mr. G. Jarreau, seconded by Mr. LeBlanc, and carried, to approve the invoices for payment.

**EVERY DAY COUNTS**

Ms. Katie Fontenot, owner of Every Day Counts, stated she is a Board Certified Behavior Analyst that opened the business a few months ago. They will be having a Walk for Autism on April 23<sup>rd</sup> in Glaser Subdivision and will be having a jump house and face painting at Glaser’s Park.

**SERVICE AWARD**

Mayor Rhett Pourciau presented Livonia Police Dispatcher, Sades Pourciau, with a 10-year service award. Police Chief Landon Landry commended Ms. Pourciau for her loyalty and dedication.

**HEARING ON CONDEMNATION OF HOUSE**

Mayor Pourciau opened the hearing regarding the proposed condemnation of a house located at 8813 Airline Highway owned by Mr. Ricky Jarreau.

Mr. Ricky Jarreau asked for a time frame of 2 months to have the house torn down. He added he has a buyer for the property after the house is torn down.

A motion was made by Mr. LeBlanc, seconded by Mr. G. Jarreau, and carried to condemn the house and allow Mr. Ricky Jarreau 60 days to have it torn down and removed, with the exception that an evaluation of its progress will be done in 4 weeks. If progress is not being made, the additional 30 days will not be allowed and the town will have it torn down.

**RESOLUTIONS**

A motion was made by Mr. T. Jarreau, seconded by Mr. Watson, and Resolved to apply to the Local Government Assistance Program (LGAP) for funding to remove the sludge at the sewer plant.

A motion was made by Mr. G. Jarreau, seconded by Mr. T. Jarreau, and Resolved to apply to the Community Water Enhancement Fund (CWEF) for funding to make water line upgrades along LA HWY 78.

**ENGINEER’S REPORT – Professional Engineering Consultants Corporation**

Mr. Gregg Gautreaux stated that no one has received funding from the Water Sector Program yet.

**DEPARTMENTAL REPORTS**

***Police Report –Police Chief Landon Landry***

In February, 430 citations were issued with 15 warnings. Two traffic accidents/incidents were worked, and 56 complaints were answered. Fines collected for the month were \$54,838.

The annual Livonia Carnival Association Mardi Gras parade day went very well. Chief Landry thanked the Livonia Maintenance Department, Pointe Coupee Parish Sheriff’s Office, and all the other agencies that contributed to this event.

***Department Reports – Council Members***

Each council member gave a brief report in their departments.

**MAYOR’S REPORT – Rhett Pourciau**

Mr. Mark Barrios inquired about having the town clean out the drainage pipes at St. Frances Catholic Church. Mayor asked Council’s opinion on a price to charge for the work.

The matter was tabled until more information could be obtained.

There will be an Easter Egg Hunt at Glaser’s Park on April 9<sup>th</sup> at 10:00 a.m. for children ages 1-11.
