

**LIVONIA TOWN COUNCIL
REGULAR MEETING
March 13, 2023 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on March 13, 2023, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

APPROVAL OF MINUTES

A motion was made by Mr. LeBlanc, seconded by Mr. Watson, and carried to approve and publish the minutes as written from the regular meeting on February 13, 2023.

APPROVAL OF TREASURER’S REPORT

A motion was made by Mr. T. Jarreau, seconded by Ms. Pourciau, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

APPROVAL OF INVOICES

A motion was made by Mr. G. Jarreau, seconded by Mr. LeBlanc, and carried, to approve the invoices for payment.

REQUEST TO CHANGE PROPERTY TO RENTAL

A request was made by Ms. Dana Porche to change her residential property at 8144 Norwood Street to rental property. All required documentation was presented, therefore a motion was made by Mr. G. Jarreau to approve the request. Motion was seconded by Mr. T. Jarreau and carried.

RESOLUTION – Municipal Water Pollution Prevention

RESOLUTION – Louisiana Compliance Questionnaire

A resolution was offered by Mr. G. Jarreau to adopt the 2022 La. Compliance Questionnaire as presented and to present a copy to Faulk & Winkler for the 2022 audit. Motion was seconded by Mr. T. Jarreau and Resolved.

DISCUSSION ON HEALTH INSURANCE FOR RETIREES

Council Member Ron LeBlanc presented for discussion different scenarios and cost analyses for the proposed health insurance for retirees. No action was taken.

DEPARTMENTAL REPORTS

Police Report –Police Chief Landon Landry

In February, 302 citations were issued with 1 warning. Four traffic accidents/incidents were worked, 44 complaints were answered, and 1 arrest was made. Fines collected for the month were \$57,088.

The handheld photo enforcement radar program’s 30-day warning period is over and the program is working well.

Livonia Mardi Gras day went well. Chief Landry thanked all departments who assisted in making the day run well, including the Livonia Maintenance Department, Mr. Brent LaCombe and his cook team, and Pointe Coupee Sheriff's Department.

Each Council Member gave brief updates on their departments.

Sewer and Abandoned Vehicles – Mr. Henry Watson

Mr. Watson stated he started the spring clean-up by picking up litter along the streets and is encouraging citizens to join in to rid the town of litter.

The second annual Pointe Coupee Community Autism Walk & 5K run will be held at Glaser's Park on April 22nd at 8:00 a.m. There will be a bake sale, jambalaya, and a jump house.
