The Livonia Town Council met in regular session at 6:30 p.m. on May 15, 2023, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call roll which resulted as follows:

APPROVAL OF INVOICES

RESOLUTION – Adopting the Millage Rate for 2023.

A resolution was offered by Mr. G. Jarreau that the millage rate of 4.83 mills for General Alimony Tax be levied on the 2023 tax roll. Mr. T. Jarreau seconded the motion and a roll call vote resulted as follows:

DEPARTMENTAL REPORTS

Police Report – Police Chief Landon Landry

In April, 347 citations were issued with 17 warnings. Six traffic accidents/incidents were worked, 42 complaints were answered, and 1 arrest was made. Fines collected for the month were \$77,918 of which \$22,251 of that amount was from handheld citation collections.

Police Officer Garrett Bergeron will be resigning effective June 27, 2023. Chief Landry recommended hiring Police Officer Robert Prestenback to fill this position beginning May 31, 2023, at \$18 per hour.

A motion was made by Mr. G. Jarreau to approve the chief's recommendation. Motion was seconded by Mr. T. Jarreau and unanimously approved.

Each Council Member gave brief updates on their departments.

Public Works – Director Ricky David

Having flow issues at the sewer plant. Presently getting prices to vacuum all the sludge out.

AT&T's lack of quality cell service is causing problems with the water well controls.

To alleviate the drainage problems on Vallet Street, the culverts and catch basins will be removed at the corner of LA Hwy. 78 and Vallet Street.
