

**LIVONIA TOWN COUNCIL
REGULAR MEETING
May 13, 2024 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on May 13, 2024, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call roll which resulted as follows:

AMEND AGENDA

A motion was made by Mr. G. Jarreau to amend the agenda to enter into a cooperative endeavor agreement with Livonia Park and Recreation. Mr. T. THE FOLLOWING WERE APPROVED

MINUTES: Motion by Mr. LeBlanc, seconded by Mr. Watson, and carried to approve and publish the minutes as written from the regular meeting on April 8, 2024.

TREASURER’S REPORT: Motion by Mr. T. Jarreau, seconded by Mr. LeBlanc, and carried, to approve the treasurer’s reports. Budget-to-actual was included for review and comments.

INVOICES: Motion by Mr. G. Jarreau, seconded by Mr. T. Jarreau, and carried, to approve the invoices for payment, except Professional Engineering Corporation. Will consult with Tony Arikol further regarding the invoice.

AWARD BID ON SALE OF 2017 Kawasaki Vehicle

A motion by Mr. G. Jarreau to award the bid to JJ Merchant for the sale of the 2017 Kawasaki Side-by-Side Utility Vehicle for \$4,277.77. Motion was seconded by Mr. T. Jarreau and carried.

REQUEST TO CHANGE PROPERTY TO RENTAL

A motion was made by Mr. G. Jarreau to approve a request by Mr. Glenn Soileau to change the property at 3951 Thorpe Street to a rental property. Mr. Watson seconded the motion and was carried.

RESOLUTION – Appoint Director and Alternate

A resolution was offered by Mr. T. Jarreau to approve the appointment of Greg Jarreau to serve as a director to the board of directors of the La. Municipal Gas Authority and to approve the appointment of Ricky David to serve as an alternate director to act in the absence of the director hereinabove named. Seconded by Mr. LeBlanc and resolved.

COOPERATIVE ENDEAVOR AGREEMENT

Mr. T. Jarreau made a motion to enter into a Cooperative Endeavor Agreement with the Pointe Coupee Parish Sheriff to provide supplemental funding for the Pointe Coupee Parish Communications District. Mr. Watson seconded the motion and was carried.

ENGINEER’S REPORT – Mr. Gregg Gautreaux

Mayor Pourciau rejected the quote received on April 10, 2024, for the repairs to the wastewater treatment plant due to there not being sufficient time to submit quotes from the date advertised to the date of opening. Will rebid.

Police Report –Police Chief Landon Landry

In April, 255 citations were issued with 10 warnings. Five traffic accidents/incidents were worked and 45 complaints were answered. Fines collected for the month were \$82,565.

Each Council Member gave brief updates on their departments.

COOPERATIVE ENDEAVOR AGREEMENT

Jarreau made a motion to enter into a Cooperative Endeavor Agreement with Livonia Parks and Recreation, Inc. to assist the Town with the operation and maintenance of all parks owned by the town. AUDIT REPORT – 2023
