

**LIVONIA TOWN COUNCIL
REGULAR MEETING
November 9, 2020 - 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on November 9, 2020, in the Livonia Council Chambers, 3111 LA Hwy. 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

APPROVAL OF MINUTES

DEPARTMENTAL REPORTS

Police Report – Police Chief Landon Landry

In October, 406 citations were issued with 13 warnings. Four traffic accidents/incidents were worked, three arrests were made, and 52 complaints were answered. Fines collected for the month were \$37,088.

Water/Gas and Dangerous Structures - Council Member Greg Jarreau

Mr. Ricky Jarreau, 8813 Airline Hwy., was served a letter of non-compliance on junk. He has been slowly making improvements. Will keep monitoring the property.

Grass Department – Council Member Terry Jarreau

Several notifications were given to property owners in violation of the grass ordinance. The hay fields have been cut.

Street Department – Council Member Warren Pourciau

Pointe Coupee Council Member Kurt Jarreau informed him that there may be more money available through the road rehabilitation program early next year to repair more streets in the town. Mayor Pourciau asked Mr. Pourciau to get a list of the streets recommended.

MAYOR'S REPORT – Mayor Rhett Pourciau

Mayor reported that the Trunk or Treat at Glaser's Park went well. Attendance was sparse possibly due to the pandemic. He thanked all the businesses who supported this event along with Ms. Melissa Armond and the JAG group for assisting.
