REGULAR MEETING  
November 8, 2021 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on November 8, 2021, at the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll which resulted as follows:

**APPROVAL OF MINUTES**

**APPROVAL OF TREASURER’S REPORT**

**NEW INTERNET PROPOSAL**

Mr. Matt Decker, owner of Able Cable, stated he would like to expand his business to include the installation of underground fiber for a new internet service in the area, and asked for the Mayor and Council’s support.

**ENGINEER’S REPORT – Mr. Gregg Gautreaux – Professional Engineering Consultants**

Mr. Gautreaux reported the Water Sector Program application was submitted and will be reviewed by end of the year.

**DEPARTMENTAL REPORTS**

***Police Report – Police Chief Landon Landry***

In October, 426 citations were issued with 4 warnings. Five traffic accidents/incidents were worked, 1 arrest was made, and 79 complaints were answered. Fines collected for the month were \$54,556.

***Department Reports – Council Members***

***Public works and Utilities – Public Works Director/Operator Ricky David***

Interior of the water tower will be cleaned beginning Tuesday and will take approximately one week.

One of the sewer pumps on Glaser Street has been rebuilt and the other one will be sent to be rebuilt as well.

**MAYOR'S REPORT – Rhett Pourciau**

A grant for the Richfield Subdivision drainage project was approved. Surveying will start this week.

Reports were received regarding the steady price increase of natural gas since January. Letters will go out to our customers to advise them of this increase in prices to prepare for the upcoming winter months.
