ENGINEER'S REPORT – Mr. Gregg Gautreaux

Upon recommendation by Professional Engineering Consultants, a motion was made by Mr. G. Jarreau to approve a payment request for \$22,500 from Feliciana Welders for the gas line improvement project on Hobson Street. Motion was seconded by Mr. LeBlanc and carried.

Police Report – Police Chief Landon Landry

In September, 238 citations were issued with 7 warnings. Three traffic accidents/incidents were worked, 1 arrest was made, and 29 complaints answered. Fines collected for the month were \$70.717.

Upon recommendation by Chief Landry, Mr. T. Jarreau made a motion to increase the hourly wage for Officer Brett Armond to \$25 when working as a firearms instructor. Motion was seconded by Mr. LeBlanc and approved.

Chief Landry stated National Night Out at Glaser's Park on October 2nd went very well. He expressed his appreciation to all the participants and visitors.

Each Council Member gave brief updates on their departments.

Council Member Billie Pourciau made a motion to add a street light on the north end of the corporate limits on LA HWY 78. Motion was seconded by Mr. G. Jarreau and approved.

PUBLIC WORKS AND UTILITIES – Ricky David

Funding has been appropriated for the new water well through a Capital Outlay grant. The town owes much appreciation to Senator Caleb Kleinpeter and Representative Jeremy LaCombe for their support and efforts in getting our application approved.

Maringouin Utility System had an emergency waterline tie-in valve installed on LA HWY 411 where their water line and Livonia's meet in the event of a water supply issue.

MAYOR'S REPORT - Mayor Rhett Pourciau

Trick-or-Treat will be on October 31st from 6:00 pm until 7:30 pm. Party at the Park will also be held during this time at the Livonia Community Center for Halloween trick-or-treating, hot dogs, and nachos.

The following grant applications and funding were recently awarded by the state.

- \$20,000 for the Police Department to be used for the purchase of a new police unit.
- \$25,000 to be used for the cost of the sludge removal from the sewer plant.
- \$25,000 LGAP grant for drainage improvements near the cemetery on Okelousas St.
- \$1,632,000 Capital Outlay towards a new water well
