LIVONIA TOWN COUNCIL REGULAR MEETING

October 13, 2025 - 6:30 p.m.

The Livonia Town Council met in regular session at 6:30 p.m. on October 13, 2025, in the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll, which resulted as follows:

THE FOLLOWING WERE APPROVED

MINUTES: Motion by Mr. Bergeron, seconded by Mr. T. Jarreau, and carried to approve and publish the minutes as written from the regular meeting on September 8, 2025.

TREASURER'S REPORT: Motion by Ms. LeJeune, seconded by Mr. L. Jarreau, and carried, to approve the treasurer's reports. Budget-to-actual was included for review and comments.

INVOICES: Motion by Ms. LeJeune, seconded by Mr. Webre, and carried, to approve the invoices for payment.

AWARD CONTRACT – Water Line Improvements

Bids were opened on October 8, 2025, for water line improvements on Thorpe Street. Motion by Mr. Bergeron to award the contract to JNG III Construction with the lowest bid of \$44,500. Motion seconded by Mr. Webre. Carried. This project is funded with two (2) Community Water Enhancement state grants.

ENGINEER'S REPORT - Mr. Gregg Gautreaux

Other screen options are being researched to handle the issue at the sewer plant.

MAYOR'S REPORT – Mayor Rhett Pourciau

Trick-or-Treat in Livonia will be held on October 30th from 6:00 pm until 7:30 pm. Party at the Park will be held at the same time at the Livonia Community Center.

Police Report – Police Chief Landon Landry

In September, 496 citations were issued with 5 warnings. Four traffic accidents/incidents were worked, and 58 complaints were answered. Fines collected for the month were \$84,365.

Glaser Subdivision will be closed for trick-or-treat to allow for foot traffic only.

The third National Night Out was held at the Pointe Coupee Parish Rec Center on October 8th. Chief Landry thanked all the vendors who participated.

Public Works and Utilities – Ricky David

Since the number of work-release laborers has reduced to only one, a part-time worker, Garrett Whittington, has been hired to assist the department with the workload.

Supplies are currently being delivered to begin the gas and water replacement project.

Each Council Member gave a brief update on their department.

Junk, Park, and Recreation – Brian Bergeron – Most property owners are complying with junk cleanup. Five have been cleaned and seven are pending. One property owner was summoned to court due to noncompliance within the time given.

According to Paul Armand, the Livonia Park and Recreation committee has a master plan for Glaser Park that is being finalized before presenting it to the council.

Beautification and Abandoned Buildings – Twanna LeJeune – Six companies were contacted to submit a bid on the landscaping and bed maintenance of the three Welcome Signs on Airline Highway. Only two companies responded. A motion was made to award the flower bed maintenance contract to Third Coast Lawn, Landscape, and Sod. Motion was seconded by Mr. Bergeron and carried.

The new website will go live within a week or two.

Addressing more abandoned property sites.

An application was recently submitted to the Keep Louisiana Beautiful program for trash receptacles at Glaser Park.

Water and Abandoned Vehicles – Lorne Webre – Three nuisance vehicles have been removed, and three are pending.

Will be proposing an ordinance regarding the regulation of junkyards, salvage yards, and wrecker yards to require fencing.

Town Attorney Steve Marionneaux stated for the record that he could not advise the town on this particular subject due to a conflict of interest.
