

**LIVONIA TOWN COUNCIL
REGULAR MEETING
September 8, 2025 – 6:30 p.m.**

The Livonia Town Council met in regular session at 6:30 p.m. on September 8, 2025, in the Livonia Council Chambers, 3111 LA HWY 78, Livonia, Louisiana. Mayor Rhett Pourciau called the meeting to order and directed Town Clerk Donna Bergeron to call the roll, which resulted as follows:

THE FOLLOWING WERE APPROVED

MINUTES: Motion by Mr. T. Jarreau, seconded by Mr. Bergeron, and carried to approve and publish the minutes as written from the regular meeting on August 11, 2025.

TREASURER'S REPORT: Motion by Mr. T. Jarreau, seconded by Mr. Webre, and carried, to approve the treasurer's reports. Budget-to-actual was included for review and comments.

INVOICES: Motion by Mr. Bergeron, seconded by Mr. T. Jarreau, and carried, to approve the invoices for payment.

RESOLUTION

A resolution was introduced by Mr. Webre, designating one (1) used 2013 Chevrolet Tahoe (police unit) as surplus property. Motion seconded by Mr. Bergeron. Motion carried to declare the vehicle surplus and to authorize its sale at a minimum price of \$10,000.

MAYOR'S REPORT – Mayor Rhett Pourciau

DOTD will hold a public meeting on September 9th at 5:00 pm regarding closing the guard rails along US HWY 190 west of LA HWY 77. The hearing will be held at the Livonia Community Center.

After persistent requests, Jenkie Lane has finally been paved by Pointe Coupee Parish Government.

Police Report –Police Chief Landon Landry

In August, 539 citations were issued with 9 warnings. Two traffic accidents/incidents were worked, and 39 complaints were answered. Fines collected for the month were \$95,243.

National Night Out will be held at the Pointe Coupee Parish Rec Center on October 8th.

Each Council Member gave a brief update on their department.

Junk, Park, and Recreation – Brian Bergeron - Regarding junk, four properties have been cleaned up, and 4 are pending.

Drainage and Streets – Terry Jarreau – Hanging tree limbs have been cleared; overgrown brush has been cleaned up on LA 78.

Water and Abandoned Vehicles – Lorne Webre – Six nuisance vehicles have been removed, and two are pending.
